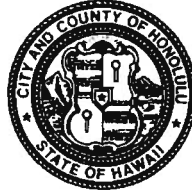

Probation Ended for Senor Frog's

Club Pink Rose Completes Second Quarterly Probation Review

HONOLULU (Aug. 13, 2009) – The Honolulu Liquor Commission (HLC) took the following action at its 7th meeting of the fiscal year on Aug. 13, 2009.

During the public hearing portion of the meeting, the Commission:

- Approved the application from **Incha Yang** (dba **Mokauea Mart**) for the transfer of the business and Retail General license at 414-E Mokauea St..

During the preliminary hearing and requests portion of the meeting, the Commission:

- Approved the application from **Fresh Catch LLC** for the transfer of the business and Retail General license of **SMP Inc.** (dba **The Beer Express**) at 45-1048 Kam. Hwy., and for a change of trade name to **Fresh Catch LLC**.
- Approved the application from **JB Unlimited, Inc.** (dba **Nolbunae Chicken**) at Makaloa Plaza, 1526 Makaloa St., for a Restaurant General license (Cat. 1 - Standard Bar).

- Fri., Aug. 28, 2009; and Sat., Aug. 29, 2009, to 2:00 am the following day; provided that liquor service in the temporary extension area stops at 1:30 am.
- Approved the waiver request from **Next Door Partners LLC** (dba **Next Door Partners LLC**) at 43 N. Hotel St., to pick up its liquor license for the 2009-2010 license year after the July 31, 2009 deadline; provided that the pick up must be completed within 60 days of the July 31, 2009 deadline.
 - Approved the waiver request from **Thanh Van Huynh** (dba **Pho One**) at 1617 Kapiolani Blvd. to pick up its liquor license for the 2009-2010 license year after the July 31, 2009 deadline; provided that the pick up must be completed within 30 days of the July 31, 2009 deadline.

During the other business portion of the meeting, the Commission:

- Heard the second quarterly probation report of the one-year probationary period of **Clevenger, Inc.** (dba **Club Pink Rose**) (fka **Club Hilltop**) at 743 K Waiakamilo Rd.
- Heard the probation report on the three-month extension to the six-month probationary period of **La Rana Hawaii LLC** (dba **Senor Frog's**) at 2201 Kalakaua Ave. The Commission terminated the licensee's probationary status.
- Heard a report on liquor licenses currently held in safekeeping.
- Ratified the Administrative Actions Report for July 2009.
- Heard a report from the Administrator regarding event scheduling and work plan coordination for the upcoming 90 days.
- Met in executive session with Corporation Counsel and the Administrator to discuss personnel and employment matters.
