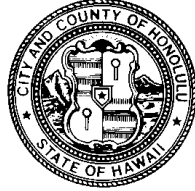

**Commission fines Ojiya, Hale Vietnam Restaurant, Tamura Super,
Therapy Sports Grill, Maile Pink Market and Yuens Grocery & Liquor Co Ltd
for selling, serving or furnishing liquor to a minor**

HONOLULU (March 17, 2009) – The Honolulu Liquor Commission (HLC) took the following action at its 33rd meeting of the fiscal year on March 12, 2009.

- **Ojiya** (no contest), **Hale Vietnam Restaurant** (no contest) and **Tamura Super** (no contest) each were fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor).
- **Therapy Sports Grill** (no contest), **Maile Pink Market** (no contest), and **Yuens Grocery & Liquor Co Ltd** (no contest) each were fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor). The Commission suspended \$250 of each fine provided the licensees receive no similar violation within one year.
- The adjudication against **Waianae Market** for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor) was continued to March 19, 2009.

During the public hearing portion of the meeting, the Commission:

- Approved the application from **Food Pantry, Ltd.** (dba **Accents**) for a Retail General license at 2259 Kalakaua Ave. (**Royal Hawaiian Hotel**).

During the preliminary hearings portion of the meeting, the Commission:

- Approved the application from **Goma Inc.** (dba **Goma Tei Ramen**) for a Restaurant Beer and Wine license (Cat. No. 1 – Standard Bar) at 1450 Ala Moana Blvd., Store No. 1215 (**Ala Moana Shopping Center**).
- Approved the amended application from **Pueo's Inc.** (**Pueo's Bar & Grill**) for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 91-1111 Geiger Rd.
- Approved the request from **Hae Won Park** (dba **Toho Japanese Restaurant-Café**) to permanently extend its licensed premises.

During the other business portion of the meeting, the Commission:

- Continued until May 14, 2009, a motion for waiver of Rule 3-82.45.2 to allow filing of application for Dispenser General, Cat. No. 4 (Hostess) liquor license within 500 feet of an existing Dispenser General, Cat. No. 4 (Hostess) liquor license from **Keith M. Kiuchi, Esq.**, on behalf of **ATG Enterprises, Inc.** (dba **Cheers Station**) at 746 Kohou St.
- Reviewed the six-month probationary period of **Kralk Enterprises, Ltd.** (dba **Club Komo Mai**) and terminated the probation.
- Continued until March 19, 2009 the review of the six-month probationary period for **The O Lounge** in order to have the licensee present.
- Heard a weekly report on administrative matters from the Liquor Administrator.
