The Honolulu Liquor Commission (HLC) took the following action at its 27th meeting of the fiscal year on Jan. 24, 2008:

- The adjudications against **Eastside Grill** (HRS Sec. 281-78(b)(1)(A) – sale to minor; penalty phase only) and **Aki-No-No** (HRS Sec. 281-78(b)(1)(A) – sale to minor; penalty phase only), were continued to Jan. 31, 2008.
- **Michael's Restaurant and Sports Lounge** (no contest), **Cisco's Cantina** (no contest), and **Tiares Sports Bar & Grill** (no contest) each were fined \$500 for a violation of HRS 281-78(b)(1)(A) (selling liquor to a minor).
- **Kailua Bowling, Inc.** (no contest) was fined \$600 for a violation of HRS 281-78(b)(1)(A) (selling liquor to a minor).
- **Zippy's** (no contest) and **Kinalau Mini-Mart** (no contest) each were fined \$750 for a violation of HRS 281-78(b)(1)(A) (selling liquor to a minor).
- **Fastop** (no contest), **2 Go Tesoro** (no contest), **Mikawon II** (no contest), and **Waikiki Parc Hotel** (no contest) each were fined \$1,000 for a violation of HRS 281-78(b)(1)(A) (selling liquor to a minor).
- **Star Super Market** (no contest) was fined \$2,000 for a repeat violation of HRS 281-78(b)(1)(A) (selling liquor to a minor).
- The adjudications against **Keo Enterprises, Inc.**, **Hilton Hawaiian Village**, and **Hatsuhana Restaurant** were continued to the next available setting.

During the public hearings portion of the meeting, the Commission:

- Approved the application from **Nomura Financial, Ltd.** for the transfer of the business and Hotel General license of **Ai Hotels Corporation** (dba **Waikiki Gateway Hotel**) at 2070 Kalakaua Ave.
