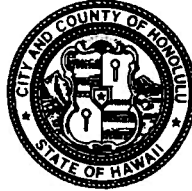

The Honolulu Liquor Commission (HLC) took the following action at its 28<sup>th</sup> meeting of the fiscal year on Jan. 31, 2008:

- **Lulu’s Waikiki Surf Club** (no contest) was fined \$250 each for two violations of Rule 3-82-38.5(e) (employee registration not readily available), \$250 for violation of Rule 3-82-38.4(c) (unauthorized payroll registration), \$1,000 for violation of Rule 3-84-79.1 (obstruction of Commission operations), and \$1,000 each for two violations of Rule 3-86-101.5 (sale/service/consumption by minor). In addition, the Commission placed the licensee on three-months probation, during which time the premises will be monitored by the enforcement section, and required the licensee to meet with the Commission’s training officer and enforcement section to evaluate its compliance efforts.
- **Honolulu Jaycees** (found guilty) was given a letter of reprimand for a violation of HRS 281-78(b)(1)(A) (sale/service/consumption by minor).
- **Wahoo’s Fish Taco** (no contest) was fined \$750 for a violation of HRS 281-78(b)(1)(A) (sale to minor).
- **“Los Garcias” Mexican Restaurant** (guilty), **Buona Sera Ristorante** (no contest), **Aki-No-No** (no contest), and **Chubby’s Pantry** (guilty) each were fined \$1,000 for a violation of HRS 281-78(b)(1)(A) (sale to minor). In addition, the Commission ordered **“Los Garcias” Mexican Restaurant** to have the licensee and all servers meet with the training officer and the Acting Chief Investigator for training. **Buona Sera Ristorante** was also ordered to attend server training.
- **Eastside Grill** (no contest) and **Pacific Beach Hotel** (no contest) each were fined \$2,000 for a repeat violation of HRS 281-78(b)(1)(A) (sale to minor).
- The adjudication against **Moana-Surfrider Hotel** was continued to the next available setting.

During the public hearings portion of the meeting, the Commission:

- Approved the application from **Nashnal Hospitality Inc.** (dba **Snappers Tap and Tapas**) for a Dispenser General license (Cat. 3 – Live Ent.) at Discovery Bay Ctr., 1778 Ala Moana Blvd.

In a related matter, the Commission approved the application from **Tenkaippin Hawaii Inc.** (dba **Tenkaippin**) for a Temporary Restaurant Beer & Wine license (Cat. 1 – Standard).
- Approved the application from **Rick’s Restaurants Ltd.** (dba **Tanaka of Tokyo West**) (Restaurant General, Cat. 2 – Live Ent.) for a change of location to the Ala Moana Ctr., 1450 Ala Moana Blvd.
- Approved the application from **Kapolei Italian Restaurant Inc.** (dba **Assaggio Kapolei**) for a Restaurant General license (Cat. 2 – Live Ent.) at 777 Kamokila Blvd.
- Approved the application from **Two Hatsuhana, Hawaii, Inc.** (dba **Hanajuban**) for transfer of capital stock and notification of new officers, director, and stockholders.
