The Honolulu Liquor Commission (HLC) took the following action at its 29<sup>th</sup> meeting of the fiscal year on Feb. 7, 2008:

- The adjudication against **Petite Garlic** (Rule 3-82-31.2(a) - conducting business outside of class/category; Rule 3-82-38.9(a) - no manager on duty) was continued to Feb. 21.
- The adjudication against **Club Golden Gate** (Rule 3-82-38.5(a) - unregistered employee; Rule 3-84-78.042 - fondling; Rule 3-84-78.01(b) - employee drinking on duty; Rule 3-82-38.4(b) - inadequate time card) (certain matters for penalty phase only) was continued to Feb. 28.
- The adjudication against **Club New D'Amour** (Rule 3-84-78.042 - fondling; Rule 3-84-78.01(b) - employee drinking on duty; Rule 3-82-38.4(b) - inadequate time card) (certain charges withdrawn) was continued to Feb. 28.
