The Honolulu Liquor Commission (HLC) took the following action at its 30th meeting of the fiscal year on Feb. 14, 2008:

- **Club Yuri** (nka **Maya's**) (no contest) was fined \$250 for a violation of Rule 3-82-38. 4(b) (inadequate time card).
- **Emerald City** (nka **New All In**) (guilty) was fined \$500 for a violation of Rule 3-83-62(a) (unauthorized alterations).
- **Club Aria Restaurant** (nka **Club Sakura**) (no contest) was fined \$1,000 for a violation of Rule 3-84-78.042 (fondling), \$300 each for two violations of Rule 3-84-78.01(b) (employee drinking on duty), and \$250 each for two violations of Rule 3-82-38.4(b) (inadequate time card).
- **Banzai Sushi Bar** (no contest) received a letter of reprimand and **Big City Diner** (no contest) was fined \$500 for a violation of HRS 281-78(b)(1)(A) (sale to minor).
- **Ginza Kimuraya Tokyo** (default) and **Jazz Minds Art & Café** (guilty) each were fined \$1,000 for a violation of HRS 281-78(b)(1)(A) (sale to minor).
- The adjudications against **The O Lounge** (Mar. 20), **Bikini Cantina** (Mar. 6), and **Verbano Italiano Ristorante** (Feb. 28) for a violation of HRS 281-78(b)(1)(A) (sale to minor) were continued to the indicated dates.

During the public hearings portion of the meeting, the Commission:
