Commission Approves Restaurant General License for Mexico Restaurant at 1247 North School St. HONOLULU (June 13, 2008) – The Honolulu Liquor Commission (HLC) took the following action at its 48th meeting of the fiscal year on June 12, 2008.

- The adjudication against **Café Che Pasta – A Bar and Grill** for violation of section 281-78(b)(1)(A), HRS (selling liquor to a minor) was continued until July 10, 2008.

During the public hearing portion of the meeting, the Commission:

- Approved the application from **Agustin Cardenas Torres (dba Mexico Restaurant)** for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 1247 North School St. In addition, the Commission requested HLC enforcement to monitor noise levels at the establishment for the first three months of the license.

During the preliminary hearings and license portion of the meeting, the Commission:

- Approved the application from **William Gladstone International Marketing, Inc. (dba William Gladstone Imports)** for a change of location from Pier 2, 521 Ala Moana Blvd. to 501 Sumner St., Suite 502. The Commission also requested the licensee to provide updated financials before the public hearing.
- Approved the application from **Galaxy Steak House LLC** for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 2301 Kuhio Ave., Suite 201A (Waikiki Town Center). The Commission also requested the applicant to update their personal history affidavit and amended the application to include the mezzanine as part of the licensed premises.
- Approved the application from **H.F. Hawaii Enterprises, Inc. (dba Crouching Lion)** for a Temporary Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 51-666 Kamehameha Hwy., the current site of **Michael's Restaurant and Sports Lounge**.
