**Commission fines Ko Olina Marina Bistro, C 'N N Mini Mart & Liquors, Chen's Store,  
Shinso Tei and Ocean Sports Restaurant & Bar for violations**

**HONOLULU (June 27, 2008)** – The Honolulu Liquor Commission (HLC) took the following action at its 50<sup>th</sup> meeting of the fiscal year on June 26, 2008.

- **Ko Olina Marina Bistro** pled no contest, **C 'N N Mini Mart & Liquors** pled no contest and **Chen's Store** pled no contest and each licensee was fined \$350 for violation of Rule 3-82-38.9(a) (2) (failing to have a duly registered manager or assistant manager assigned to the licensed premises).
- The violation against **Foodland Super Market Ltd. [Limited] No. 37** for violation of Rule 3-82-38.9(a) (2) (failing to have a duly registered manager or assistant manager assigned to the licensed premises) was withdrawn. The Commission issued a warning to the licensee.
- **Shinsho Tei** pled no contest and **Ocean Sports Restaurant & Bar** pled no contest and each licensee was fined \$125 for violation of Rule 3-82-38.9(g) (failing to ensure registered manager had his/her certificate of registration readily available for inspection while on duty).

During the public hearing portion of the meeting, the Commission:

- Approved the application from **S.H. Lee, Inc.** for the transfer of the business and Dispenser General license (Cat. No. 3 and 4 – Live entertainment or Recorded Music and Dancing; and Hostess) of **H.S. Brickhouse, Inc.** (dba **Club Golden Gate**) at 98-199 Kamehameha Hwy., G-2.
- Approved the application from **Nicos LLC** for the transfer of the business and Restaurant Beer and Wine license (Cat. No. 1 – Standard Bar) of **Pacific Ocean Producers, LLC** (dba **Nico's**) at 1133 North Nimitz Hwy.
- Approved the application from **Royal Hawaiian Showroom, LLC** (dba **Waikiki Nei**) for a Cabaret General license at 2201 Kalakaua Ave, Suite B401 (**Royal Hawaiian Shopping Center**).

During the preliminary hearings, license and request portion of the meeting, the Commission:

- Approved the application from **1004 Corporation** for the transfer of the business and Dispenser General license (Cat. No. 4 – Hostess) of **Kapiolani Discount Store, Inc.** (dba **Café Woel Chool Bong**) at 1679 Makaloa St. and for a change of trade name to **Woel Chool Bong**. The Commission also approved a Temporary Dispenser General license.
- Took no action and requested the item to be rescheduled due to no appearance by the applicant regarding the application from **DC Restaurants, LLC** (dba **Buon Amici Ristorante**) for a Restaurant General license (Cat. NO. 1 – Standard Bar) at 3605 Waialae Ave.
- Approved the application from **Langham Corporation** (dba **Banana Leaf Italian Bistro**) for a Restaurant General license (changed to a Cat. No. 1 – Standard Bar – from a Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 2919 Kapiolani Blvd., Space No. 221 (**Market City Shopping Center**).
- Approved the application from **Shimas Market Inc.** for the transfer of capital stock at 41-1606 Kalaniana'ole Hwy.
- Approved the request from **F.L. Inc.** (dba **Don Ho's Island Grill**) to temporarily extend its licensed premises from 1 p.m. to 11 p.m. on July 13, 2008.
