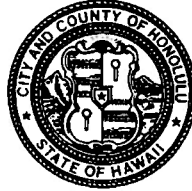

Commission ends probation for Lulu's Waikiki Surf Club and denies waiver request from Saigon Passion III to file an application for renewal of their Cabaret General license for fiscal year 2008-2009

HONOLULU (July 18, 2008) – The Honolulu Liquor Commission (HLC) took the following action at its second meeting of the fiscal year on July 10, 2008.

- The adjudication against **Honolulu Tavern** for violation of Rule 3-82-38.23(b) (noise) was continued until Aug. 21, 2008. Relating to the same licensee, the Commission continued to Aug. 21, 2008, a request to remove the common elements from the licensed premises and a request to cancel approval for installation of a karaoke system.
- The two adjudications against **Fashion 45** for violation of Section 281-78(b)(1)(A), HRS (licensee sold, served or furnished intoxicating liquor to a minor) were continued until July 24, 2008.

During the public hearing portion of the meeting, the Commission:

- Left the public hearing open and continued the application until July 31, 2008 regarding the matter from **K & E 909, Inc. (dba 909 Mini Mart)** for a Retail General license at 909 Kapiolani Blvd.
- Approved the application from **ONE, Inc. (dba Tokoname Sushi Restaurant)** for a Restaurant General license (Cat. No. 1 – Standard Bar) at 442 Uluniu St.

During the license and request portion of the meeting, the Commission:

- Approved the application from **Bronson Phanphongsa (dba New Blue Ocean Entertainment)** for a Special General license on July 25, 2008 at 111 North King St., 2nd Floor (**Yee Hop Plaza**).
- Continued the request until July 24, 2008 from **The Shack Mililani LLC** for approval to accept an application for extended Caterer License at 95-221 Kipapa Dr.

During the Other Business portion of the meeting, the Commission:

- Heard a three-month probationary status report on **Waikiki Lulu's, LLC (dba Lulu's Waikiki Surf Club)** and ended their probation status.

- Denied the matter from **Robert H. Nakata, Esq.**, on behalf of **TMNPS Corporation (dba Saigon Passion III)** requesting waiver of Rule 3-82-31.4 and Rule 3-81-17.53 to be permitted to file an application for renewal of Cabaret General license No. I0029 for fiscal year 2008-2009, pursuant to Rule 3-81-17.8.
