**Akasaka Restaurant, Wailana Coffee House, Restaurant Kuni, Kirin Restaurant Incorporated  
and Round Table Pizza receive fines for selling, serving or furnishing liquor to minors**

**- Probations terminated for Komoko LLC (dba Fashion 45) and Shenanigans LLC (dba Mad Dog Saloon) -  
HONOLULU (Jan. 9, 2009)** – The Honolulu Liquor Commission (HLC) took the following action at its 24<sup>th</sup>  
meeting of the fiscal year on Jan. 8, 2009.

- **Akasaka Restaurant** (default), **Wailana Coffee House** (no contest) and **Restaurant Kuni** (no contest) each were fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor).
- **Kirin Restaurant Incorporated** (no contest) and **Round Table Pizza** (no contest) each were fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor). The Commission suspended \$250 of each fine provided the licensee receives no similar violation within one year.
- The adjudication against **The O Lounge** for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor) was continued until Jan. 22, 2009.
- The adjudication against **Choon Chun Chicken BBQ** for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor) was continued until the next available setting.
- The Commission accepted a no contest letter from **Harbor Pub & Pizza, Inc.** for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor) and continued the penalty phase of the adjudication to Jan. 29, 2009.

During the public hearings portion of the meeting, the Commission:

- Approved the application from **KOLL LLC (dba Nanea Hale)** for a Dispenser General license (Cat. No. 3 – Live entertainment or Recorded Music and Dance) at 92-102 Waialii Place (**Beach Villas at Ko Olina**).
- Approved the application from **Silvert & Saibene Wines, LLP** for a Wholesale Beer and Wine license at 521 Ala Moana Blvd., Pier 2, Foreign Trade Zone No. 9.

During the preliminary hearing, license applications and requests portion of the meeting, the Commission:

- Approved the application from **SEASIDE 364 LLC** (dba **Matteo's Italian Restaurant**) for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 364 Seaside Ave. (lobby level of **Marine Surf Waikiki**).
- Approved the application from **Murphy's Inc.** (dba **Murphy's Bar & Grill**) for a change of kind and category from a Dispenser General license (Cat. No. 1 – Standard Bar) to a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 2 Merchant St.
- Approved the application from **Emcube, Inc.** (dba **Creations in Catering**) for a Caterer license to cater off the licensed premises to 4997 Kahala Ave. (**Waialae Country Club, Greenside Lanai**) from Jan. 15 to 18, 2009.

During the other business portion of the meeting, the Commission:

- Reviewed the six-month probation for **Komoko, LLC** (dba **Fashion 45**) and terminated the probation.
- Reviewed the six-month probation for **Shenanigans LLC** (dba **Mad Dog Saloon**) and terminated the probation.
- Heard a weekly report on administrative matters from the Liquor Administrator.
