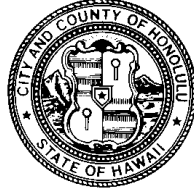

Commission fines Stadium Foods for selling, serving or furnishing liquor to a minor HONOLULU (May 8, 2009) – The Honolulu Liquor Commission (HLC) took the following action at its 40th meeting of the fiscal year on May 7, 2009.

- **Club Texas** (no contest) was fined \$1,000 for violation of Rule 3-82-38.20(b) (permitting liquor of any kind, to be open and readily consumable after the hours established by the Commission, to wit, 2:08 a.m.).
- **Stadium Foods** (no contest) was fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor).
- **Leeward Bowl** (no contest) received a letter of reprimand for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor).

During the public hearings portion of the meeting, the Commission:

- Approved the application from **M & S Retail Store, Inc.** for the transfer of the business and Retail General license of **JYS Incorporated** (dba **Bobo's Mini Mart**) at 98-064 Kamehameha Hwy.
- Approved the application from **Goma Inc.** (dba **Goma Tei Ramen**) for a Restaurant Beer and Wine license (Cat. No. 1 – Standard Bar) at 1450 Ala Moana Blvd., Store No. 1215 (**Ala Moana Shopping Center**).
- Approved the application from **Pueo's Inc.** (dba **Pueo's Bar & Grill**) for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 91-1111 Geiger Rd. (**Coral Creek Golf Course**).

During the preliminary hearings and request portion of the meeting, the Commission:

- Approved the application from **SSK Corporation** for the transfer of the business and Retail General license of **Tanabe Superette, Inc.** (dba **M.S. Tanabe Superette**) at 934 Keeaumoku St., and for a change of trade name to **Tanabe Market**.
- Approved the application from **Food Pantry, Ltd.** (dba **Accents**) for a Retail General license at 1811 Ala Moana Blvd. (2nd floor, **Grand Waikikian Tower, Hilton Hawaiian Village**).

- Approved the add-on to the agenda and approved the application from **Seven-Eleven (Hawaii), Inc.** (dba **7-Eleven Stores**) for a Retail General license at 98-1277 Kaahumanu St. (**Waimalu Shopping Plaza**).
- Denied the request for continuance and found the cancellation to be effective regarding a request from **FIT, LLC** (dba **Hang Loose Sports Bar**) for reinstatement of Dispenser General License No. E1465, which was voluntarily cancelled on April 27, 2009.

During the other business portion of the meeting, the Commission:

- Heard the first quarterly review of a one-year probationary period (Feb. 12, 2009 to Jan. 14, 2010) from **Clevenger, Inc.** (dba **Club Hilltop**, nka **Club Pink Rose**).
- Heard a weekly report on administrative matters from the Liquor Administrator.
- Met in Executive Session to confer with counsel regarding personnel and employment matters, in accordance with HRS 92-5(a)(2).
