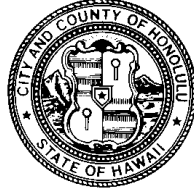

Probation for La Rana Hawaii LLC (dba Senor Frog's) extended three months

- Commission also fines Walter T. Fujikami Florist, Inc. for selling, serving or furnishing liquor to a minor - HONOLULU (May 15, 2009) – The Honolulu Liquor Commission (HLC) took the following action at its 41st meeting of the fiscal year on May 14, 2009.

- **Walter T. Fujikami Florist, Inc.** (no contest) was fined \$1,000 for violation of Section 281-78(b)(1)(A), HRS (selling, serving or furnishing liquor to a minor). The Commission suspended \$500 of the fine provided the licensee receives no similar violation within one year.
- The adjudications against **Silk Lady Lounge** for three violations of Rule 3-84-78.042 (fondling), three violations of Rule 3-84-78.01(b) (employee consumption of liquor while on duty on the licensed premises), three violations of Rule 3-84-78.01(c) (licensee's employee solicited or accepted food or beverage as a gift from or at the expense of a customer while on duty on the licensed premises) and four violations of Rule 3-82-38.4(b) (time card) were continued to Sept. 3, 2009. A fifth violation of Rule 3-82-38.4(b) (time card) was withdrawn.

During the preliminary hearing, special license and request portion of the meeting, the Commission:

- Approved the application from **HFWP, LLC (dba Hawaii Food & Wine Paradise)** for a Special General license on May 21 and 23, 2009 at 92-1101 Aliinui Dr. (**Lanikuhonua**); a Special General license on May 21, 2009 at 92-1220 Aliinui Dr. (**Ko Olina Golf Club**); a Special General license on May 22, 2009 at 92-1089 Aliinui Dr. (**Paradise Cove Luau**); a Special General license on May 22, 2009 at 92-161 Waipahe Pl. (**Marriott's Ko Olina Beach Club**); and a Special General license on May 21, 2009 at 92-1220 Aliinui Dr. (**Roy's Ko Olina**).
- Approved the application from **Jesus Santoyo (dba Just Tacos Pearl City)** for a Restaurant General license (Cat. No. 2 – Live entertainment or Recorded Music and Dancing) at 1029 Makolu St, Suite B (**Pearl City Shops**).

- Approved the application from **Sun Ann Hong, LLC** (dba **Black Diamond Nightclub**) for renewal of its Temporary Cabaret General license for a term of two weeks from the June 12 expiration to June 26, 2009.
- Approved the application from **Slow Down Town LLC** (dba **Downtown**) for a Caterer license to cater off the licensed premises to **Honolulu Academy of Arts** at 900 South Beretania St. on May 29, June 26, July 31, Aug. 28, Sept. 25 and Oct. 30, 2009. In a related matter, the Commission approved a request to withdraw Application No. 1565 (granted on April 30 but not yet issued) from **Basic Food Group LLC** (dba **Town**) for a Caterer license to cater off the licensed premises to **Honolulu Academy of Arts** at 900 South Beretania St. on May 29, June 26, July 31, Aug. 28, Sept. 25 and Oct. 30, 2009.
- Approved the request from **Lily Koi Restaurant and Lounge LLC** for approval of the transfer of membership interest and notification of admission of members.
- Approved requests from **F.L. Inc.** (dba **Don Ho's Island Grill**) to temporarily extend its licensed premises from 10 p.m. on May 23 to 2 a.m. on May 24, 2009, and from 3 p.m. to 11:30 p.m. on May 24, 2009.
- Approved the request from **CB Beachwalk Inc.** to permanently extend its licensed premises to include the common area walkway and three balconies fronting its premises at 226 Lewers St., Suite L200.
- Approved the request from **Paesano at Waimalu LLC** to permanently alter and extend its licensed premises at 98-1277 Kaahumanu St.

During the other business portion of the meeting, the Commission:

- Granted a Motion from **Keith M. Kiuchi**, on behalf of **ATG Enterprises, Inc.** (dba **Cheers Station**) for a waiver of Rule 3-82.45.2 to allow filing of application for Class 5, Dispenser General, Cat. No. 4 (Hostess) liquor license within 500 feet of an existing Class 5, Cat. No. 4 (Hostess) liquor license.
- Ratified the Administrative Actions Report for April 2009.
- Heard a review of a six-month probationary period (Nov. 13, 2008 to April 30, 2009) from **Fat Friday's, Inc.** (dba **Moose McGillycuddy's Pub & Café**) and ended the licensee's probation.
- Heard a review of a six-month probationary period (Nov. 13, 2008 to April 30, 2009) from **La Rana Hawaii LLC** (dba **Senor Frog's**) and extended the licensee's probation for three months.
- Heard a weekly report on administrative matters from the Liquor Administrator.
- Met in Executive Session to confer with the Liquor Administrator and counsel regarding personnel and employment matters, in accordance with HRS 92-5(a)(2).
