

***Following the July 28, 2016 continued public hearing for the Kuraudia USA, Ltd. application, it was determined that the number of valid protests from registered voters or owners and lessees of record of real estate/owners of record of shares in a cooperative apartment within 500 feet of the premises met the level to require denial of the license application as required by HRS 281-59. When advised of the situation, Kuraudia USA, Ltd. voluntarily cancelled the license on September 8, 2016. Although the license was effective between these two dates, no liquor sales or service was conducted on the premises by Kuraudia USA, Ltd.**
