ITEM NO. 2 – REQUEST FOR QUALIFICATIONS, PRE-SUBMITTAL CONFERENCE


PRE-SUBMITTAL CONFERENCE, Page 6 of the Request for Qualifications shall be deleted in its entirety and replaced with the following:
