

NOTICE TO CONSULTANTS
REQUEST FOR CONSULTANT SERVICES

The City and County of Honolulu, Department of Transportation Services, is seeking a qualified Consultant to Design and Modify Traffic Signals at various intersection locations on Oahu. The Project constitutes the seventh phase of an ongoing Federal-Aid Program, STP-0001(28), to install or Modify Traffic Signals at Various Locations on Oahu. The new traffic signals will be installed at the following intersections:

- 1) LEILANI STREET AND SCHOOL STREET
- 2) CALIFORNIA AVENUE AND ULUKU STREET
- 3) BERETANIA STREET AND KAIALIU STREET
- 4) KALAKAUA STREET AND FERN STREET

The traffic signal locations that will be modified are as follows:

1. KALAELOA BOULEVARD AND MALAKOLE STREET (UPGRADE SIGNAL)
2. KUAKINI STREET AND LANAKILA STREET (UPGRADE)
3. KALANIANAOLE HIGHWAY AND PAOLIMA STREET (UPGRADE)
4. LAUNAHELE STREET AND GEIGER ROAD (UPGRADE)

Consultants desiring to be considered shall provide the following information:

1. Name of firm or person, the principle place of business, and location of all its offices.
2. The age of the firm and its average number of employees over the past years.
3. The education, training, and qualifications of key members of the firm.

4. The names and phone numbers of up to five clients who may be contacted, including at least two for whom services were rendered during the preceding year.
5. A narrative of past experiences and qualifications of the firm and individuals to be involved.
6. Examples of similar design projects the firm has completed within the past five (5) years including cost and date of construction.
7. The firm will be required to perform the work in an office located in Honolulu, and complete their work within the specific time limitations of the contract.
8. Conflict of interest in performing services for the City and County of Honolulu.
9. Federal Funds will be used for this project, therefore, the qualified firm maybe required to submit DBE/WBE information.
10. Any other pertinent data that should be considered in the evaluation of the firms qualifications (Standard Form 255 is recommended as a format to provide this information) and any other promotional or descriptive literature which the firm desires to submit.
