**QUESTIONS AND RESPONSES**

The following questions were timely received in the Transit Mailbox. The responses provided by the Honolulu Authority for Rapid Transportation (HART) are as follows and are herein incorporated as part of the RFP:

Question #32:

RFP ITO Section 6.2.b.ii requests that we include an express statement from each of the equity members of the entity to confirm their joint and several liability. Our Firm is a limited liability partnership and is covered by rules of professional conduct under legal regulatory bodies in the jurisdictions in which we operate. Would such a statement be considered an appropriate response?

**Response #32:**

**Without waiving any rights provided to HART under law, whether, without limitation, statutory, regulatory, or common law, an express statement from each of the equity members of the entity confirming joint and several liability is not required. Offerors**

**shall ensure they review and comply with Section 4.4, Insurance, of the HART General Conditions for Professional Services (v. 3/2017).**

**Question #33:**

RFP ITO Section 4.10, please confirm if HART requires a Hawaii licensed attorney for the Project.

**Response #33:**

**Offerors shall be familiar with and be in full compliance with the Rules of Hawaii State Supreme Court, the Hawaii Rules of Professional Conduct, and applicable Hawaii Revised Statutes.**


**Question #34:**

Please confirm that the requirement to provide joint and several liability statements described in Section 6.2.(b) is limited to joint ventures as provided in Section 1 of Exhibit 2, and does not apply to other forms of organization.
