SUBJECT: Bill 18 (2016), CD2, FD1, Relating to HART Operating Budget;
Bill 19 (2016), CD1, FD1, Relating to HART Capital Budget; and
Bill 20 (2016), CD1, FD1, Relating to Authorizing the Issuance and
Sale of General Obligation Bonds and Bond Anticipation Notes in
the Principal Amount Equal to the Aggregate of the Amounts
Appropriated by the City Council in the HART Capital Budget
Bill 19 (2016), CD1, FD1

I am returning, unsigned Bill 18 (2016), CD2, FD1; Bill 19 (2016), CD1, FD1; and Bill 20 (2016), CD1, FD1 which, respectively, relate to the operating budget for Honolulu Authority for Rapid Transportation (HART), to HART's capital budget, and to the issuance and sale of general obligation bonds and bond anticipation notes in the principal amount equal to the aggregate of the amounts appropriated by the City Council in the HART capital budget Bill 19, CD1, FD1. Not only does the Revised Charter of the City and County of Honolulu (2000 ed.), as amended (RCH or Charter), not afford the City Council the degree of fiscal oversight reflected in these three bills *per se*, Bill 20 (2016), CD1, FD1 is also not authorized by the RCH Article XVII, Public Transit Authority (Article 17), as it is premised on the City Council appropriation for HART's capital projects.

Prior communications to the City Council¹ contain the background and details about the extent of the City Council's legislative authority under the Charter to enact ordinances relating to HART monies and the HART budgets.
