SUBCHAPTER 1

GENERAL PROVISIONS

**§12-3-1 Purpose.** The purpose of this chapter is to establish certain fees for admission to the Honolulu Zoo.

**§12-3-2 Definitions.** (a) "Resident of Hawaii" means every individual domiciled in Hawaii.

- (1) Residents of Hawaii may verify their current address using documents such as:
  - (A) Valid State of Hawaii driver's license;
  - (B) Valid State of Hawaii identification card with expiration date;
  - (C) Checkbook with name and address imprinted;
  - (D) Current rental agreement;

- (E) Current utility bill;
- (F) Proof of any insurance coverage issued to the person; or
- (G) Postmarked envelope mailed to customer within the last fourteen days.

(2) If Residents of Hawaii present verification of their current address using (1) (C)-(G) above, they must also verify their identity using one or more of the following picture IDs to satisfy the required proof:

- (A) Current passport;
- (B) Current military identification;
- (C) Current school identification;
- (D) Current alien registration card;
- (E) Any current identification issued by any government agency; or
- (F) Current company-issued ID.

(b) "Nonresident of Hawaii" means every individual other than a Resident of Hawaii.

**§12-3-3 Admission Fees.** (a) The following daily admission fees will be assessed for the Honolulu Zoo:

- (1) Nonresident of Hawaii, three to twelve years of age: Eleven dollars per person.
- (2) Nonresident of Hawaii, thirteen years of age and older: Nineteen dollars per person.

(b) All other admission fees for the Honolulu Zoo are set by ordinance.
