CONFLICT RESOLUTION PROCESS

The department shall apply the following conflict resolution criteria for permit applications requesting the same block of dates, not enough cooling off period and too many competition days requested on the calendar.

A permit application and Application Supplement shall be scored in three categories, see below. (For more specific details refer to the Title 19, Chapter 4, City and County of Honolulu Administrative Rules entitled “Shore Water Events” Section 19-4-12.) Please submit written responses to categories 1, 2, and 3 on no more than two letter-sized, single sided pages per category. Maps or diagrams may be submitted in addition to those responses.

1. Plans for Compliance with Permit Conditions (50% of total score)
 - a. Plans to comply with all department rules and regulations
 - b. Plans for cleaning and stocking of restrooms
 - c. Plans to keep the grounds clean and removal of trash collected from the park
2. Plans to mitigate community impact (40% of total score)
 - a. Plans to mitigate traffic congestion
 - b. Plans to address parking concerns and an overall parking plan
 - c. Plans to control crowds attending the event
 - d. Plans to address access by local residents and government services (keep access to trash collection, U.S. mail, emergency vehicles, delivery services, etc.)
 - e. Plans to control noise generated from the event
3. Diversity of Event Calendar (10% of total score)
 - a. Type of event: (long board surfing, short board surfing, bodysurfing, body boarding, standup board surfing, other)
 - b. Level of competition (amateur, pro-am, professional)
 - c. Age of Participant (under 18 years of age, over 18, over 65)
 - d. Gender of participants
