YOU MAY CONTEST THE REMOVAL OR FEE BY WRITTEN REQUEST FOR HEARING SUBMITTED NO LATER THAN 25 DAYS FROM DATE OF REMOVAL TO:

The written request must provide (1) your current mailing address; (2) that the hearing is being sought pursuant to Section 29-16.3(d) of Revised Ordinances of Honolulu, as amended; (3) a short and plain statement of all pertinent facts, including a copy of this Notice or sufficient information about the removal and the property removed; and (4) a short and plain statement of the relief requested and the reasons for the relief.

YOU MAY SEEK A WAIVER OF THE FEE IF PAYMENT WOULD BE FINANCIALLY ONEROUS FOR YOU BY PROPERLY FILING AN APPLICATION (AVAILABLE AT THE DEPARTMENT OF FACILITY MAINTENANCE AT THE ADDRESS ABOVE) NO LATER THAN 25 DAYS FROM THE DATE OF REMOVAL.

YOU MAY RECLAIM PERSONAL IDENTIFICATION, BIRTH CERTIFICATES, PRESCRIPTION MEDICATION, MOBILITY DEVICES, AND OTHER ITEMS THAT ARE NECESSARY, ESSENTIAL OR INDEISPENSIBLE TO DAILY LIFE WITHOUT A FEE AND WITHOUT A HEARING.

UNLESS ANY CONTEST THAT IS TIMELY FILED IS UPHELD, PROPERTY OWNER SHALL PAY A \$200 FEE FOR ALL COSTS OF REMOVAL, STORAGE AND HANDLING OF REMOVED PROPERTY.
